



Terms & Conditions (For Sponsors, Exhibitors and Advertisers)

- ✓ All booking forums must be accompanied by 50% advance and remaining 50 % must be paid before possession of stall/start of conclave. Written confirmation of booking will be given only after 100% advance payment.
- ✓ The Exhibition Committee shall allocate the floor areas to meet the request of exhibitors as far
 as possible to their given preferences but the same cannot be guaranteed by the Exhibition
 Committee.
- ✓ An official receipt towards provisional booking amount shall be issued within three week receipt of payment.
- ✓ The site of the stall shall be made available to the participants a day before the exhibition begins. No workman will be allowed at the exhibition site after 10.00 am of the Inauguration day under any circumstances. If the participants fail to occupy the stall by 9:00 am of the inauguration day, the exhibition committee reserves the right to allot the vacant stall to the waiting applicants.
- ✓ The organizer reserves the right to change the venue and date of exhibition in case of unavoidable circumstances.
- ✓ No sale in cash or credit of product and service shall be allowed at the stalls. However, booking could be done for delivery at later date. The Exhibition Committee shall no way be responsible for any tax liability incurred for any sale / booking transaction undertaken by the exhibitors.
- ✓ Companies wanting to import equipment or consumable for exhibition purpose should inform to our Official Event Manager at the time of booking to enable us to obtain International trade Promotion Organization (ITPO) approval for the same.
- ✓ No refunds will be made for cancellations made 5 days prior to the start of the conclave
- ✓ 50% refund will be made if bookings are cancelled 6-10 days prior to the start of the conclave
- √ 90% refund will be made if bookings are cancelled more than 10 days prior to the start of the conclave
- ✓ All refunds will be processed a week after the end of conclave
